Greetings from Human Rights Defenders Alert - India!

HRD Alert - India is a Forum of Human Rights Defenders for Human Rights Defenders. It endeavors to initiate actions on behalf of Human Rights Defenders under threat or with security concerns.

We are now writing to express our grave concern regarding the abduction and killing of RTI activist and human rights defender Mr. Bhola Sah in Bihar.

The Human Rights Defenders:

Mr. Bhola Sah was a RTI activist in the Banka district. He had exposed several financial irregularities in government social welfare schemes in his panchayat.

The Perpetrators:

Unknown assailants

Date of Incident: December 23, 2018.

Honorary National Working Secretary: Henri Tiphagne

National Coordinator: Mathew Jacob

Incident detail:

As per the source, on December 23 2018, while Mr Bhola Sah was supervising the

construction of his house in Banarjhop village in Banka district, he was asked by some men

in an SUV to accompany them to the local police station. They said he had been summoned

by the station in-charge (SHO). When he did not return home, his family members inquired

from the police official, who denied having called Mr. Sah. Later his body was later found near

an embankment with several injury marks.

From the past work of Mr. Bhola Sah as a RTI activist and human right defender, it is

anticipated that he was murdered for having exposed financial irregularities in government

social welfare schemes in his panchayat.

Appeal:

We, therefore urge you to immediately

• Order an immediate, independent, thorough, transparent, effective and impartial

investigation into the above-mentioned incident of the murder of RTI activist and

human rights defender Mr. Bhola Sah.

• Take immediate action on the perpetrators, in this case they are unknown, who should

be searched for with a nationwide alert issued and investigation done transparently

and considering all angles.

• Ensure provision of reparation, compensation, apology to the family of the defender

for the psychological sufferings they are undergoing because of the death of Mr. Bhola

Sah.

• Put an end to all acts of attack and harassment of human rights defenders in the State

of Bihar to ensure that in all circumstances they carry out their activities as defenders

of human rights without any hindrances; and,

More generally, ensures in all circumstances the respect for human rights and

fundamental freedoms in accordance with the Universal Declaration of Human Rights

and with international human rights instruments ratified by India is strictly adhered to

in the state of Bihar.
